at the Institute for Medical Informatics, Statistics and Documentation

The Institute for Medical Informatics, Statistics, and Documentation is primarily concerned with scientific questions in healthcare and biomedicine. Its focus is on making clinical data usable for research, teaching, and patient care. This includes the development and evaluation of tools and methods in information technology (IT) and biostatistics, from data collection through processing and modelling to statistical analysis and interpretation.

The university professor will be entrusted with the following key responsibilities:

- National and international representation of the field of Medical Informatics in research, teaching, and clinically oriented IT services
- Further development and expansion of the institute's existing research priorities, particularly in Artificial Intelligence (AI), with a focus on medical knowledge management and multimodal clinical data
- Interdisciplinary collaboration with institutions and partners of the Medical University of Graz, as well
 as with other scientific and clinical stakeholders in the region
- Continuation and deepening of national and international collaborations
- Ensuring research-driven teaching in Medical Informatics in the undergraduate medical school programme (learning objectives: https://api.medunigraz.at/redirect/tQQKqGLMuflbMAkB), as well as in doctoral and PhD programs, including active involvement in the delivery and further development of academic teaching
- Promotion and supervision of early-career researchers
- Continuation of established quality and risk management processes

- Habilitation or equivalent academic qualification

- Excellent scientific expertise in the field of innovative IT solutions to support clinical and medical research, with a focus on artificial intelligence, image processing, or text analysis
- Proven international experience and active international collaborations
- Experience in the development and management of complex research projects in information technology
- Proven track record of regular acquisition of competitive (inter)national project funding
- Extensive teaching experience and educational competence at the university level
- Leadership and management experience, ideally in an academic environment
- Negotiation-level proficiency in both German and English
